Investment objective

The investment objective of the Fund aims to deliver long term capital growth, from a broadly higher risk approach to investing. The overall volatility of the portfolio is maintained within a set volatility band, which is at a level typical for a moderately adventurous risk fund.

Investment approach

The fund looks to deliver the maximum return possible for a level of risk that investors are comfortable with.

To do this, the AJ Bell Investment team uses in-house modelling to design a highly diversified portfolio combining assets including; equities, bonds and cash. This process has the consistent aim of delivering long-term returns, whilst smoothing out the worst of the market's volatility, to give a more predictable investment journey. This delivers returns efficiently, without compromising investors' tolerance for risk.

The fund will invest predominantly in derivative contracts called swaps, which allow the fund to receive a return linked to the performance of an underlying basket of assets, linked to the performance of equities, bonds and cash.

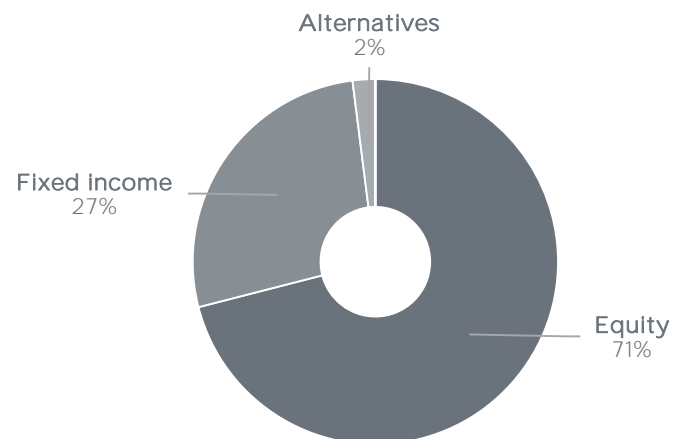
