

Terms and conditions

AJ Bell WTCS Leeds Triathlon Mixed Relay Competition

Details of the prize

1. There are three “prizes” available which vary depending on how close the guess is to the actual time.
1st place - £300 Zone3 voucher & signed, framed image of Team GBR
2nd place - £200 Zone3 voucher & event hoodie
3rd place - £100 Zone3 voucher & event mug
2. There is no cash alternative, and the prize is not transferable and non-exchangeable.

How to enter

To enter the prize draw, you must comment your prediction (in the format hours:minutes:seconds) for the finishing time of Team GBR in the mixed relay event at the AJ Bell 2022 World Triathlon Leeds on Sunday 12 June.
