

## Terms and conditions

# Nominate a care home or hospital to receive a free tablet

## Making a nomination

- You can make a nomination for a care home or hospital of your choice to receive a tablet by completing the nomination form which can be found at www.ajbell.co.uk.
- You must submit your fully completed nomination by 30 June 2020.
- You can only make one nomination and you can only nominate a care home or hospital which is registered with the Care Quality Commission.
- All nominations must include a main point of contact at the care home or hospital, who is willing and available to take delivery of the tablet and coordinate with AJ Bell. You must ensure that the point of contact has seen, understood and accepted these terms and conditions and the use of their personal information.
- By completing and submitting a nomination form, you are deemed to have accepted these terms and conditions.

### The tablet and the selection process

- We will notify you within three weeks of receiving your nomination to confirm whether or not it has been successful.
- Donations will be made on a discretionary basis by the AJ Bell Wage War on Covid Fund committee.
- Only one tablet will be provided per care home or hospital. We reserve the right to provide more than one tablet to a care home or hospital at our discretion.
- The tablet to be provided to the care home or hospital is a Huawei MediaPoint T5. If this model is not available, a tablet of a similar spec and value will be provided. There is no cash alternative and the tablet is non-transferrable and non-exchangeable.
- 10. Stock is limited and donations are therefore subject to availability.
- 11. The tablet will be provided to the care home or hospital and it will be for the care home or hospital to determine how the tablet is used, including during the lockdown period and afterwards. We are not involved in this

- process and we cannot guarantee that the tablet will be used for a particular purpose or made available for use by a specific individual, resident or patient at a care home or hospital.
- 12. The tablet will be provided "as-is", with a variety of popular apps installed. The care home or hospital will be responsible for setting up and running their own accounts and for all ongoing maintenance.
- 13. AJ Bell is not liable if the tablet is damaged or broken during use at the care home or hospital and will not provide a replacement.

#### Delivery of the tablet

- 14. Where your nomination is successful, we will contact the point of contact specified in your nomination to arrange for delivery of the tablet. Once the tablet has been dispatched, we accept no responsibility for any loss or damage that may occur in transit.
- 15. We reserve the right to reallocate the tablet if we do not receive correspondence from the point of contact within 10 days of us attempting to contact them.
- 16. You are responsible for providing complete and correct details when submitting your nomination. AJ Bell accepts no responsibility for any failure to supply accurate information which affects acceptance or delivery of the tablet.
- 17. By accepting delivery of the tablet, the point of contact is deemed to have accepted these terms and conditions.

#### Use of your personal information

We will only use your personal information for the purposes of administering this campaign, announcing successful nominations and for organising any postcampaign publicity and promotional activities, including through our social media, website and PR channels, as we deem appropriate. We will use and take care of any personal information you provide to us in accordance with applicable data protection laws. By entering you consent to our collection, retention, use and distribution of your personal information for these purposes.
