

My Triathlon Moment terms and conditions

Details of the prize

- The "prize" is one of eight 'standard' or 'sprint' distance entries in to the AJ Bell World Triathlon Leeds on Sunday 9 June 2019. See the event <u>website</u> for more details.
- 2. Prizes may differ depending on availability. If a stated prize is not available, a similar prize will be awarded.
- 3. There is no cash alternative and the prize is not transferable and non-exchangeable.
- 4. AJ Bell will not cover transport expenses in relation to the prize.

How to enter

- 5. To enter the competition you must share your triathlon 'moment' in the form of a photo or video via Twitter or Facebook using #MyTriMoment, then follow or like @AJBellGroup.
- 6. Entries are only valid if the post is public so that AJ Bell can see it.
- 7. The deadline to submit an entry is 12pm on Friday 10 May 2019.
