Commentary

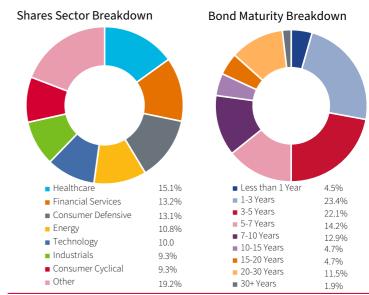
Inflation, interest rates, and the energy crisis continued to dominate market headlines in Q3 2022, as they have for much of the year. High inflation, exacerbated by the energy crisis and war in Ukraine, prompted central banks around the world to continue their path of hiking interest rates. This has been a headwind for both bonds and stocks.

UK investors also saw volatility in domestic markets caused by the new government's mini budget. This saw yields rise in government bonds and a sharp, but temporary, drop in the value of the pound. The Balanced fund is well-diversified, with international holdings that increase in value when the pound drops.

We also have a dedicated energy position within the fund that tracks the share price of companies in the energy sector. This provided some additional protection in the current economic climate.

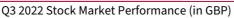
The Balanced fund holds a globally diversified portfolio of stocks and bonds. The fund was -0.2% down across the quarter, bringing the 12-month return to -2.4%.

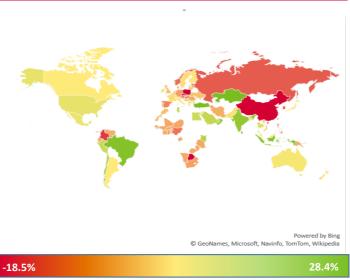
